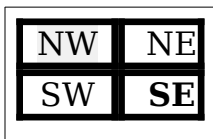


Rural Water District No. 1, Wabaunsee Co.

APPLICATION FOR WATER SERVICE AND WATER USER'S AGREEMENT

The undersigned, being the owner of land located within Rural Water District No. 1 (District), hereby makes application to said District for water service, and if water service is made available by said district, agrees to the following conditions:

1. Purchase or cause to be purchased one benefit unit for water service at the unit price of **\$12,000.00**.
2. Pay the cost of installation of said service with the water district paying the first \$2,500.00 of the installation cost.
3. Pay a monthly charge for water service from the time service is made available by the district, and pay for water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made in the monthly water service charge and rate schedule by the Board of Directors of the District shall become a part of this agreement as fully set out herein.
4. The Rules and Regulations of the District provide that the District will read the water meters on or about the 1st day of each month. The service and usage bill shall be rendered by the District on or about the 10th day of the month, and the undersigned agrees to pay said bill on or before the 5th day of the month following the month in which the bill is rendered, or be subject to a late charge. Failure of the District to submit a bill shall not excuse the undersigned from his obligation to pay for service and usage when the bill is submitted. Failure to pay a bill shall result in discontinuance of the service as set forth in the Rules and Regulations of the District.
5. The water service supplied by the District shall be for the sole use of the undersigned; the undersigned agrees that he will not extend or permit the extension of pipes for the purpose of transferring water from one property to another, nor will he share, resell, or sub meter water to any other consumer. Each meter service shall supply water to one residence or business establishment located on land within the District.
6. If after water service is made available the same is discontinued or disconnected for any purpose, pursuant to the By-Laws and the Rules Regulations of the District, reconnection shall be upon the conditions set out in the By-Laws and the Rules and Regulations of the District.
7. The undersigned agrees that he/she will make no physical connection between any private water system and the water system of the District. Representatives of the District may at any reasonable time come on the premises where the water is being used for the purpose of making inspection to enforce this provision. Violation of this provision shall be grounds for disconnection of service.
8. The Laws of the State of Kansas, the By-Laws of the District, and the Rules and Regulations of the District, as presently existing, and as may be amended from time to time, are made apart of this agreement as though fully set out herein, and are controlling and take precedence over this agreement.
